#### **Aim of the 1st Online Conference**

The first **Remote Workers Policy Hub (RWPH) Conference** will present the project's vision, structure, and next steps, and open a dialogue on how to make rural areas more attractive for remote professionals.

The conference aims to familiarize RWPH members and other participants with the project and upcoming activities, to highlight challenges and good practices within the three key policy areas through expert presentations, and to encourage joint reflection and discussion on possible improvements and development directions.

Three key policy packages will guide the discussion and expert input:
